- 2. Approval of June BHB Minutes (Action Item): Motion for June minutes approval by Jason Stooks, seconded by Megan Comstock. No discussion. Motion passed.
- 3. Financial report—Sean: We have a funding application opening in September 2025. The same process that was used last year will be used this year. We will have a total of \$15,000 to fund projects. The website will need to be updated so an announcement is made about the opening for September.
- 4. Youth & Family Wraparound Intensive Services—BPA Health--Marisa Alan: Marisa is the Outreach Coordinator and informing the community about Wraparound. She presented about the program and how to make referrals to youth and their families. She will send information to Jim and he will send it out to all.
- 5. Needs and Gaps document finalized—Sara/Board (Action Item): Not currently finished. Sara will follow up with the chair's for the subcommittees and then send the document to the Board and if no additions or corrections it will be sent to State Planning Council in Sept.
- 6. BHB DBH SUD team scholarship selection—Board (Action Item): The scholarships for a two day conference, September 4 & 5 and will be virtual. Primary focus is in workforce development initiatives related to Opioid Use Disorders. Motion to approved Board member Sharlene for the scholarship funds. Amber motioned. Seconded by Jason Stooks. No discussion. Motion passed.
- 7. Update on Sept BHB activity funding application month—Amber/Christina/Shari: Application process will be opening for funding. The funding applications will be available on the BHB Website. After they are filled out, they will be emailed to Amber and Shari. Sara and Jim will look at applications and

make sure they align with the Region 2 BHB's SPF. If it is an allowable and complete funding application, Sara and Jim will submit them with a recommendation for funding. The Board will vote on and approve the applications they want to support at the Oct BHB meeting.

- 8. Reg 2 Youth Crisis Center update—Megan/Joyce Lyons: Jean Spielman of Fletcher Group presented on the needs assessment of Youth Crisis Centers (YCC). It is recommended that a community listening session be hosted along with meeting with other Youth Crisis centers to gather information from them. Joyce discussed the current political environment as a potential struggle with getting funding for a local center. Megan discussed providing information to the community and how the center can be utilized. Discussed how the crisis centers are being under-utilized and the State and Magellan are working to address these concerns. Joyce and Megan will keep us posted on the YCC process as it goes along. There are 3 state regional YCC's.
- 9. Crisis Intervention Team (CIT) Training update—Laura: Over the past year there were different options, the traditional 32 hour sessions. They attempted to set up 1 day CIT trainings but they have not garnered much interest. April was the full CIT training about 15 participants. Last week a 1 day training was done for their 4 new officers. They will be planning the next CIT academy and there will be a CIT steering committee developed.
- 10. Riverside Recovery Reg 2 ACT team by Magellan—Sara: Sara presented on the Assertive Community Treatment program and how to make a referral
- 11. Notice of expiring Board terms on Dec 31, App deadline Oct 27—Board: Christine, Shari, Megan, Shaun, Malcom, Jenny, Amber, Sharlene terms expire and they can renew membership.
- 12. Recovery Community Center Latah/Nez Perce/Lewis Counties—Shaun/Astahna/Amber: Astahna reported 816 people came through the door. They have many meetings throughout the week. Next Month on September 13th they will host Hands Across the Bridge.

 Amber reported they had 219 in the recovery center. They had 71 different activities throughout the month. They will be hosting a dinner on September 26th.
